VOI/RPS works with community leaders to develop innovative programs that help reduce homelessness and increase financial independence for vulnerable people.



Voices of Inspiration Representative Payee Services (VOI/RPS), is a nonprofit organization appointed by the Social Security Administration and Veterans Affairs to provide SSA payee services and VA fiduciary services for individuals deemed unable to manage their own benefits.

As an appointed representative payee, it is our responsibility to manage our client's benefits. We will work with our clients to determine current needs and future foreseeable needs and use the benefits to meet those needs.

#### **Our Vision**

We envision serving a diverse population of people in California and Texas and to ensure the financial affairs of the vulnerable are administered honestly, fairly and in their best interests. Homelessness is not a condition or a preferred option for our clients. We network with other agencies helping to serve the homeless with the purpose of finding permanent housing for our homeless clients.

#### **Our Process**

Once the agreement/contract with VOI/RPS is approved, Social Security Administration (SSA) will send the client's funds to VOI/RPS. Our primary responsibility is to see that their **funds** are disbursed in the best interests of the client. VOI/RPS will be responsible for ensuring your basic needs come first, such as rent, food, and personal needs are met. This arrangement minimizes opportunities for the misuse or misappropriation of funds.

## **Our Values**

Our clients come first we are committed to serving. VOI provides budgeting classes for financial stability, structure, life skill classes, individual and group meetings. We partner with other agencies for the common goal of improving quality of life for the people we serve which instills a sense of independence.

# What is a representative payee organization?

The Social Security Administration provides financial assistance through (SSI/SSA) payments to elderly and disabled individuals. Occasionally, due to the severity of the disability or other situational factors, some of the people authorized to receive these SSI/SSA benefits are unable to adequately manage their funds. As a result, Congress has created a law whereby non-profit community based organizations are allowed to act as the individual's financial Fiduciary. Under protection of this program, the benefits are issued to a non-profit third party who then manages the funds for the individual. By law, the fees for this service are limited to \$43 per month or 10% of the benefit amount, whichever is lower. Anyone receiving SSI/SSA benefits and who may not be in a position to manage their funds are eligible for the service.
